

Terms and Conditions

These terms and conditions apply to the Debunking Modern Health Myths December Event Competition (**Promotion**) and include instructions on how to enter and win a **Prize**.

The **Promotion** commences at 11:00am (ACDT) on 2/12/2025 and closes at 12:00pm (ACDT) on 2/12/2025.

The **Prize** will be drawn at the Debunking Modern Health Myths December Event hosted by **The Promoter** at the Campbelltown Function Centre – 172 Montacute Rd, Rostrevor SA 5073 at 12:05pm (ACDT).

Eligibility and entry

Entry to this **Promotion** is open to Australian residents who (**Entrants**):

- are over the age of 18 years;
- are a current member of the **Promoter** who registers to and attends the Debunking Modern Health Myths December Member Event or are an attending **Guest** in accordance with the Terms and Conditions for the Debunking Modern Health Myths December Member Event.
