

Terms and Conditions

Member Event: Debunking Modern Health Myths 2

These terms and conditions apply to the Debunking Modern Health Myths 2 Event (**Event**) and include instructions on how to register.

This **Event** is conducted by Health Partners Limited ABN 43 128 282 904 of Level 3, 101 Pirie Street Adelaide 5000 (Phone: 1300 113 113) (**Organiser**).

The Event will be held on Tuesday 2nd December 2025 from 11:00am – 1:00pm (ACDT) at the Campbelltown Function Centre – 172 Montacute Rd, Rostrevor SA 5073.

Registrations close by 19 November 2025.

Registration

Registrations are only open to current Health Partners members (**Registrants**) who are over the age of 18 years, who are not employees or Board members of the **Organiser**, its agents or its affiliates associated with this Event, or their immediate families.

Registrants will each be permitted to bring one (**Guest**) to the event if they so choose. The **Guest** may or may not be a Health Partners Member. The **Guest** will not be required to complete the registration form to attend the event.

To register, the **Registrant** must:

- register their details with the **Organiser** via the registration form;
- provide their requested details to the **Organiser**, including Email Address
- consent to the **Organiser** collecting, using and disclosing the personal information collected in the entry for marketing purposes in accordance with the Health Partners Privacy Policy (available at <https://www.healthpartners.com.au/privacy-policy>).

Guest Registration

Registrants will be provided the option to invite one **Guest** to the **Event**. **Registrants** will be required to indicate to the **Organiser** that they intend to bring a **Guest** as part of their Entry via the registration form. The **Registrant** will not be required to provide the name of their **Guest** or any other information about their **Guest** to the **Organiser**. **Guests** will identify themselves to the **Organiser** on the day of the **Event** for the purposes of entry to the **Event** by advising at the door “I am [Member’s name]’s guest”.

General

1. Attendance at this event is strictly limited and subject to availability. Spots will be allocated on a first-come, first-served basis upon receipt of a properly completed registration.
2. Your spot is not guaranteed until you receive a confirmation email from the event **Organiser**. If the event reaches capacity before your registration is confirmed, you may be placed on a waitlist.
3. Once successfully registered to the **Event**, the **Guest** is able to attend the **Event** with or without the person who registered them unless their **Entry** is altered or revoked by the **Registrant** or the **Organiser** for any reason.
4. If all spots are filled, a waitlist will be maintained. Individuals on the waitlist will be notified if a place becomes available, in the order their registration was received.
5. If you and your **Guest** can no longer attend, please notify the **Organiser** as soon as possible so **Organiser** can offer your spots to someone on the waitlist.
6. The **Organiser** is not required to accept any registration not complying with these terms, including any late, lost, misdirected, incomplete or incorrect registrations or registrations which are not received by the **Organiser's** systems. Errors and omissions may be accepted at the **Organiser's** discretion.
7. Spots are non-transferable unless approved in writing by the **Organiser**.
8. If this **Event** is not capable of running as planned or is interfered with in any way due to any reason beyond the reasonable control of the **Organiser**, the **Organiser** reserves the right (subject to all relevant State and Territory legislation), to cancel, terminate, modify or suspend the **Event**.
9. The **Organiser** reserves the right to alter these terms to extend the close date for registrations if all spots have not been filled by the original registration close date.
10. The **Organiser's** decision (acting reasonably) in relation to any aspect of the **Event** is final. The **Organiser** reserves the right to disqualify any registration that the **Organiser** knows or reasonably suspects has provided false information, breached these terms, tampered with any registration process or has otherwise engaged in any activity which is unlawful or improper in connection with this **Event**.

11. Nothing in these terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010* (Cth) or similar consumer protection laws Australia (**Non-Excludable Guarantees**).
12. Failure by the **Organiser** to enforce any of its rights at any stage does not constitute a waiver of those rights.
